VENDORS MUST ABIDE BY LAWS ON THIS LINK, RULES ON THIS PAGE & SIGN WAIVER

Welcome to the Tanner Gun Show. **We appreciate** our partnership and want you to know we continually strive to insure a safe and profitable show. Therefore, we require that you know, abide by, and help us enforce the general show rules for exhibitors:

- **1. No Loaded Guns.** ABSOLUTELY NO LOADED GUNS ARE ALLOWED IN THE SHOW. This includes concealed carry, and any dealer side arms. All guns must be zip tied, and handguns should be tethered during show hours Any loaded gun will lead to **permanent dismissal** from Tanner Gun Show.
- 2. VENDORS and service dogs MUST USE CUSTOMERS' ENTRANCE & EXIT DURING SHOW HOURS,

do not use any side doors-things get stolen 🕾

3. Your table is required to be **open** with aisles cleared by 9AM SAT and remain open during *all show hours*, no one under any circumstance is allowed to start packing up until the Show closes. If you have an emergency and must leave, please contact Tanner personnel. **BEING TARDY** *might* **AFFECT YOUR PLACEMENT**

SECURITY HOURS: FRIDAY 2PM-SUNDAY 6PM

4. <u>HELPERS</u>: Your first table gets you two helper wrist bands for a total of THREE PEOPLE included and each additional purchased table gets you one additional wrist band.

If the helpers are coming during show hours do not collect wrist bands but put their names on our HELPERS LIST which is found at the front desk or cashier station during show hours.

If you have a rotating crew, we require a (limited) list of names by Friday midday and ask that you tell each shift where the table is.

5. NO DOGS ALLOWED:

The average dog bite settlement is just under 50k

- **6. Subletting of Tables.** There will be absolutely NO subletting of tables without prior approval of one of the show managers. If you sublet any portion of your tables, you are personally responsible for the merchandise and actions of your sublessee
- **7. Tanner Gun Show provides tables and chairs.** The Colorado State Fire Marshal requires that we have a minimum amount of space between each aisle. **BEFORE OR AFTER THE SHOW** please DO NOT rearrange, tape, move, **SIT ON**, or in any way change the way your tables and or aisle is set up as each row has been set to Fire Code. If you are the last vendor to leave on Sunday, please close all doors including overhead doors.
- **8. No Shows.** Any tables that have not been claimed (i.e., which do not contain dealer merchandise) by 8:30am on Saturday will revert to the show and may be given away or resold. No refunds will be given. If you have a problem on the way to the show and are going to be late, please contact Tanner personnel and we will work with you.
- **9. Cancellations.** No refunds or credit will be given on tables cancelled less than 1 week before the show or for anyone who is a no show for any reason (including weather). Credit will be given for a future show only if you inform us at least 7 days prior to the show that you will not be coming.

- **10. Sales Tax.** Be advised that you are solely responsible for collecting sales tax on your sales and for being familiar with the tax rules regarding your business. The **COLORADO STATE DEPARTMENT OF REVENUE SALES TAX DIVISION** may request a vendor list or pass out tax forms but I will announce often if they do.
- 11. Gun Stickers. All exhibitors selling guns and conducting their own background checks will be issued customized COLOR CODED stickers (available at the front desk) that must be placed on any firearm that is sold. PLACE STICKER ON GUN BOX WHEN POSSIBLE, if not then on the firearm please. Without this sticker your customer will not be allowed to leave the building with a firearm. This will enable us to verify that the gun has been purchased (not stolen) and the required background check WITH 72 HOUR WAITING PERIOD were conducted. It is the exhibitor's responsibility to not only pick up gun stickers at the front desk to follow our rules but also obey everything covered here:

- **12.** Customer Firearms. Every firearm which a customer brings into the show will be checked by security at the entrance to ensure the gun is unloaded and zip tied at which time a special sticker will be placed on the firearm. No Exhibitor may handle or offer to buy any customer's firearm that does not have this sticker and/or is not zip tied, verifying it was checked at the front door. During show hours, it is the responsibility of every exhibitor to immediately report to our security staff any firearm that is not stickered and/or zip tied.
- **13. Parking Lot Transactions.** Dealers are not permitted to transact ANY business in the parking lots. <u>Anyone making gun sales in the parking lots will be banned from all future shows</u> and the appropriate law enforcement personnel will be notified.
- **14. Sales Outside Show Hours.** While at the show, dealers are not permitted to transact any business with the public outside normal show hours. Anyone making sales to the public outside normal show hours will be banned from future shows.
- **15. Soliciting in Aisles.** <u>VENDORS MUST REMAIN BEHIND THEIR TABLES WHILE CONDUCTING SALES.</u> You are not permitted to stand in the aisles and/or in front of your tables to solicit show attendees.
- **16. Prohibited Items.** Tanner Gun Show retains the right to have any exhibited items it deems to be in poor taste or otherwise inappropriate (in its sole discretion) to be modified or removed. This includes but is not limited to guns prohibited for sale under state law, explosives, bombs, incendiary devices, pornography, or illegal items of any kind.
- **17. No Loose Ammo.** No loose rounds of ammunition may be on your tables. Likewise, **ammunition may NOT** be placed in any magazine, cylinder, chamber, or barrel. Ammo must be boxed or placed in sealed plastic bags.
- **18. Security.** Although we provide security at the show, it is the **dealer's responsibility** to secure all items on your tables. We strongly encourage you to use glass cases for small valuable items and security cable locks on any handguns that are displayed outside of a glass case. Once the show closes on Sat, simply cover your table with a tarp or bed sheet as we have overnight security inside the building.
- **19. Compliance with Laws.** By exhibiting any items at our show, you agree to abide by all local, State, and Federal laws as well as all show rules. **Safety is our primary concern**.
- **20. Failure to Follow Rules.** Failure to follow these rules may lead to eviction from the show. In such event no refunds will be given.
- **21. Open Records**. At the request of Tanner management, you agree to make available to Tanner personnel, all records of guns sales, rentals, exchanges and purchases made at a Tanner show.
- 22. Sound. Loud or repetitive sounds (bells, dings, music, etc.) at vendor tables is strictly prohibited.
- 22. THEFT IS ALL TOO COMMON TODAY, DO NOT LEAVE MERCHANDISE UNATTENDED. This includes in your "locked trailer/vehicle" at the venue or hotel parking lot.
